The Village Administrator reported he is completing the necessary paper work as to Govdeals.com for the auction sale of several items of equipment.

Adam Cupp of Fawcett, Lammon & Recker Insurance, was present to discuss the medical insurance renewal. Medical Mutual of Ohio renewal for 2011-2012 has increased the premium by 16.24%. Mr. Cupp stated other entities have received premium increases up to 37%. Thus, the village's increase is at the low end for the new contract year. Mr. Cupp also presented coverages and costs of other health care carriers. These comparisons showed Medical Mutual of Ohio's premium costs and coverages are quite competitive with other carriers. Discussion was also had as to proposed changes in the health care industry. The majority of these changes are planned to take effect in 2014. At this time there is no way to know for sure how these proposed changes will be implemented. Mr. Cupp stated he would keep us informed as to the proposed new health care laws and
