ORDINANCE NO. 535-2012:

RECOUPMENT ORDINANCE TO PROVIDE FOR ADDITIONAL CHARGES FOR PROPERTIES CONNECTING TO THE ST. JOHN WATER SUPPLY AND SANITARY SEWER SYSTEM EXTENSION WICH SUCH CONNECTION CHARGES TO BE DETERMINED, AS SET FORTH HEREIN, SO AS TO DISTRIBUTE AS EQUITABLY AS POSSIBLE AMONG THE USERS OF THE ST. JOHN EXTENSION THE COST OF SAID EXTENSION, AND ALLOWING ST. JOHN MENNONITE CHURCH THE OPPORTUNITY TO RECOUP SOME OF THEIR OUT OF POCKET COSTS FOR SAID EXTENSION.

The Village Administrator reported on the following: 1) The hydrant located by the St. John Mennonite Church parking lot was flushed due to the fact the water quality (taste) was poor. Approximately 27,000 gallons was used to flush said hydrant. At this time unsure how many times this hydrant will need to be flushed to keep the water from becoming stale and stagnant. Discussion was had regarding said water used to flush the hydrant; if possibly sell it to a farmer, or some other way to recoup some of the costs of this water usage. 2) A draft letter addressed to the Deputy Director of ODOT in Lima, Ohio, was presented regarding the Road 5 Improvement Project. The main focus of the letter states the safety concerns as to the intersection of Road 5 and State Route 12. Discussion was had as to this letter and project. Several possible changes and additions were discussed as well. A final draft will be e-mailed to the Council prior to mailing the same to the ODOT office in Lima.

Fiscal Officer, Lana Burry, presented financial information as to increase in the electric expenses, the reduction of state monies to be received this year as well as some possible ways to help reduce expenses.

Motion was made by Mr. Vance, seconded by Mr. Swary to excuse Mr. Fricke and Mr. Painter from this meeting. Voting: All Yea.
