Minutes of

RECOUPMENT ORDINANCE TO PROVIDE FOR ADDITIONAL CHARGES FOR PROPERTIES CONNECTING TO THE ST. JOHN WATER SUPPLY AND SANITARY SEWER SYSTEM EXTENSION WICH SUCH CONNECTION CHARGES TO BE DETERMINED AS SET FORTH HEREIN, SO AS TO DISTRIBUTE AS EQUITABLY AS POSSIBLE AMONG THE USERS OF THE ST. JOHN EXTENSION THE COST OF SAID EXTENSION, AND ALLOWING ST. JOHN MENNONITE CHURCH THE OPPORTUNITY TO RECOUP SOME OF THEIR OUT OF POCKET COSTS FOR SAID EXTENSION. Motion was made by Mr. Painter, seconded by Mr. Hall to adopt Ordinance No. 535-2012 as read for its third and final reading. Voting: All Yea.

ORDINANCE NO. 536-2012:

AN ORDINANCE APPROVING, ADOPTING AND ENACTING AMERICAN LEGAL PUBLISHING'S OHIO BASIC CODE 2012 EDITION, AS THE CODE OF ORDINANCES FOR THE MUNICIPALITY OF PANDORA, OHIO. Motion was made by Mr. Fricke, seconded by Mrs. Buess to place Ordinance No. 536-2012 on its second reading. Voting: All Yea.

The Village Administrator reported on the following: 1) The Scott Gratz property is in the flood plain and thus the Village is not in compliance under the guidelines of the flood management program. Possibly one way to take care of this matter is to submit a LOMA (Letter of Map Amendment) report. Greg Bockrath, who prepared the elevation survey, has previously prepared these reports for a fee of \$500. After some discussion, a motion was made by Mr. Fricke, seconded by Mrs. Buess for the village to hire Mr. Bockrath to prepare the LOMA report for a fee of \$500. Voting: Painter-Aye; Vance-Nay; Fricke-Aye; Hall-Aye; Buess-Aye. 2) Discussion was had as to the storm sewer project to alleviate the water problem primarily at the Gary Hilty residence. It has also been brought to the attention of the Council that several other residents in this area have water drainage problems as well, and they also could tap into this line. 3) Received a quote from Fremont Fence as to a fence in front of the dugouts for a cost of \$2,455 and to install, straighten and repair another section of fence at the same ball field at a cost of \$607. It was the consensus of the Council to proceed with this project. 4) Discussion was had as to the Hempfling farm located to the south of the real estate recently annexed into the Village. The property owners are in agreement as to annexation into the village and an option for future economic development.

Councilman Painter suggested to reduce expenses, for the village to pay for work clothes for the village employees(Street Department, Water/Sewer Department and Village Administrator) and they in turn launder their own instead of renting uniforms from Miller Textile and the company returns clean ones to the employees on a weekly basis. The Village Administrator is to obtain quotes as to the cost for said uniforms.

Discussion was also had as to posting ordinances and resolutions as opposed to having the notices printed in the newspaper. It was the consensus of the Council to have all future adopted ordinances and resolutions posted at five prominent locations in the village.

Motion was made by Mr. Painter, seconded by Mr. Vance to move into Executive Session to discuss Personnel. Voting: All Yea. (Time: 8:20 PM). Motion was made by Mr. Painter, seconded by Mr. Fricke to move from Executive Session to Regular Session. Voting: All Yea. (Time:8:35PM).

With no further business to discuss, the meeting was adjourned upon a motion by Mr. Vance, seconded by Mr. Painter. Voting: All Yea.
