Motion was made by Mr. Fricke, seconded by Mr. Painter to adopt Resolution No. 2012-618 as read for its third and final reading. Voting: All Yea.

EMERGENCY RESOLUTION: A RESOLUTION TRANSFERRING FUNDS FROM THE GENERAL FUND TO THE PARK FUND.

RESOLUTION NO. 2012-620:

EMERGENCY RESOLUTION: A RESOLUTION FOR TEMPORARY REDISTRIBUTION OF

INCOME TAX REVENUE. Motion was made by Mr. Fricke, seconded by Mr. Hall to suspend the rules by which Resolution No. 2012-620 be read on three separate occasions. Voting: All Yea. Motion was made by Mr. Vance, seconded by Mr. Swary to adopt Resolution No.2012-620 as an emergency measure. Voting: All Yea.

The Village Administrator reported on the following: 1) The water tower was inspected and cleaned by Liquid Engineering on September 9, 2012. They have two recommendations as to security measures. The hatch and the vents should be re-vamped for security purposes to protect the integrity of the water tower as well as the protection and safety of village residents. 2) Steck Painting was contacted to submit a quote as to painting the EMS building. The quote should be available for the next meeting. 3) Received an estimate from Tawa Tree Service as to the removal of stumps. They estimated approximately \$50 per stump. Thus the estimated cost to remove 58 stumps would be \$2,900. Since the Village could receive up to 87.5% in FEMA funds, the village would be out of pocket of approximately \$362.50. It was the consensus of the Council to proceed with the removal of these stumps. 4) The Village Administrator and Fiscal Officer will be meeting with a FEMA representative on Friday, September 14, as to the storm damage of June 29, 2012. 5) The EPA has given the village until September 1, 2013 to be in compliance according to the NPDES permit as to phosphorus levels in the lagoons.

6) As to replacement of the four-way flasher on Main Street, the village will not be in compliance for insurance purposes if a fourway flasher is installed without the erection of a stop sign at each intersection. This matter was tabled for further review of this matter. 7) Discussion was had as to the proposed easements to help alleviate the water problem at the Gary Hilty residence. Village Solicitor, Scott Basinger, stated several of the residents located on Sherman Street and/or G Street, since they are not having any water problems, expressed their desire not to sign an easement for a storm sewer to be erected on their property. Also if this proposed storm sewer installation would only benefit one or two residents in this area, the cost for this project may not be in the best interest of the village. It was the consensus of the Council to further review this matter.

Discussion was had regarding the property located at 105 Pearl Street. It has come to the attention of Village Administrator, Stanley Schneck, this property has not been, as of this date, tied into the new sanitary sewer. This may be the reason several residents in the area have experienced sewer back up during heavy rains. Mr. Schneck will contact the owner of the property to tie into the new sanitary sewer.
