\$60,000 would be for these repairs. 2) Beaverdam Contracting has been drawing water in the Village for the Road 5 project. When the project is completed, a bill will be sent to them for the use of this water. 3) The football team is working on the playground area this evening in hopes of completing the placement of stone. This is the only time they will have to do this work. If it is not completed this evening, the Village will contact the Putnam County Juvenile Probation Office for any of those individuals who need to do community service work to complete this project.

Discussion was had as to the phosphorus situation of our lagoons. The Village Administrator has been in contact with the Village of Ansonia as to their plan for reducing the phosphorus levels. He also has been in contact with Richard Wahl and a colleague, Brian Brown, as to this matter. After some discussion, the Council agreed to have Richard wahl to come to the next council meeting to discuss this matter. The Council would also like for Mr. Brown to present a proposal as to being a consultant for this project.

Police Chief, Scott Stant, stated Silas Augsburger has completed his police officer training and has received his certification. Chief Stant asked the Council to hire Mr. Augsburger as a part-time police officer. It was the consensus of the Council to hire Silas Augsburger as a part-time police officer for the Village.

Mayor Schlumbohm gave an overview of the meeting the Village Council had with the Riley Township Trustees. Regarding the new fire truck, the cost will be capped at \$75,000, of which the Village would be responsible for \$37,500 of this cost. As to the annexation of 75 acres to the village and the proposed agreement with the Trustees as to the real estate tax revenue, The Trustees stated they are satisfied with said agreement. This agreement states the Township Trustees will continue to receive real estate tax revenue, based on agricultural value, even when the original 15 year period has expired.
