RESOLUTION NO. 2013-626:

RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY AUDITOR.

Motion was made by Mr. Vance, seconded by Mrs. Buess to place Resolution No. 2013-626 on its second reading. Voting: All Yea.

The Village Administrator stated he had prepared a draft letter to be sent to Ohio EPA as to what the village has done and is doing as to the phosphorus levels in the lagoons.

Also the Village Administrator presented to Council a proposed Cooperative Agreement between the Putnam County Commissioners and the village to be a collaborative partner in applying for grant funds for the purpose of a water/sewer district study. Also a proposed Resolution was presented to authorize Stanley Schneck to enter into this agreement. There were various concerns as to this proposed agreement such as possible expenses the Village may incur for this study. This matter was tabled. A representative from Poggemeyer Design Group, who prepared these documents, is requested to attend a council meeting to discuss the concerns of the Council.

Motion was made by Mr. Vance, seconded by Mrs. Buess to excuse Mr. Painter and Mr. Swary from this meeting. Voting: All Yea.

Adam Cupp, of Fawcett, Lammon & Recker and United Insurance Service, was present to discuss the upcoming medical insurance renewal for the village as well as health care reform issues. In regards to the renewal package, the total premium increase is 10.29%, effective "grandfathered", if no changes are made they will remain "grandfathered". In light of this fact October 1, 2013. At the present time those policies which have been In light of this fact, a number of the health care reform issues will not be a factor for the Village's current policy. Mr. Cupp stated the exchange rates will not be available until after Labor Day, so therefore, he could not give us a definitive answer as to the premium cost of the proposed renewal medical policy effective October 1, 2013, in relation to the exchange rates. It was the consensus of the Council for Mr. Cupp to meet with the Council and the village employees to discuss the proposed renewal policy as well as the health care reform issues once these rates become available.

with no further business to discuss, the meeting was adjourned upon a motion by Mr. Fricke, seconded by Mr. Vance. Voting: All Yea.
