Discussion was had regarding possible solutions to reduce the phosphorus levels in the lagoons. One suggestion was the possibility of aerating the lagoons. It was the consensus of the Council to have various lagoon samples taken and submit to the Village of Ottawa for aeration testing. Also the University of Findlay has been conducting various studies regarding phosphorus reduction in wastewater treatment facilities. Thus, the University will be contacted as to their studies on this matter. Also Mr. Richard wahl has a colleague who would be willing to discuss this matter to Council as well. Mr. Schneck will be contacting Mr. Wahl to have his colleague come to a future council meeting.

Tuesday, July 9

Councilman, Kevin Swary, stated at the last council meeting there was a misstatement as to Police Officer, Kyle Hall's, present wages which is \$12.00 per hour. To be on the same wage scale as our newest employee, Seth Rosselit, Mr. Hall's hourly wage should be \$12.50 per hour. Mr. Swary stated that since Mr. Hall's 60-day probationary period is within a few days of expiring, he recommended Mr. Hall's hourly wage be \$13.50 per hour, effective July 1, 2013. It was the consensus of the Council to approve Kyle Hall's hourly wage of \$13.50, effective July 1, 2013.
