The Village Administrator reported on the following: 1) Discussion was had as to the village's contribution to the Putnam CIC for 2013. Motion was made by Mr. Fricke, seconded by Mr. Hall to contribute \$2,000 to the Putnam CIC for 2013 year. Voting: All Yea. 2) Discuss the real estate tax distribution of the proposed annexation of real estate with the Trustees at their next meeting. The Village Council agrees to the Trustees receiving the real estate taxes on the 75 acres proposed to be annexed for economic purposes for 15 years after which time the taxes would revert to the Village. Mayor schlumbohm stated he would present this matter at Trustees next meeting, which is on April 4th. 3) Presented quotes from two mowing services regarding mowing the two park areas as well as other locations in the village. The quotes were rather high, and not cost effective. It was the consensus of the Council to either hire an individual, as an independent contractor, to do mowing only, or to continue to do the mowing ourselves. 4) Discussion as to ordering flowers for this year. It was the consensus of the Council for the village to purchase approximately four pots of flowers and the remainder to be purchased by the Chamber of Commerce.
