Motion was made by Mr. Swary, seconded by Mr. Eisenbach to place Ordinance No. 547-2014 on its first reading: Voting: Liechty-Aye; Buess-Aye; Swary-Aye; Burkholder-Nay; Eisenbach-Aye; Miller-Aye.

Michael J. Bohrer, Putnam County Probate/Juvenile Court Judge spoke to the Council in seeking re-election of said judgeship.

The Riley Township Trustees, Fiscal Officer of the Trustees and Fire Chief, Jason Kinsinger, were present to discuss the upcoming purchase of the new fire truck. The approximate cost is \$75,000, which the Village's share would be approximately \$37,500. The Fire Department is not planning on any other major expenditures this year.

The Village Administrator reported on the following: 1) The stop light at the intersection of Jefferson Street and Main Street is now working. Discussion was had regarding making it a four-way stop. The existing stop light can be re-programmed to a red, four-way flashing light. A motion was made by Mr. Liechty, seconded by Mr. Eisenbach to change the stop light at the intersection of Main Street and Jefferson Street to a red, four-way flashing light. Voting: All Yea. 2) Regarding new water meters, E.J. Prescott will present their proposal to the Council at the February 25, 2014 meeting. 3) The P-G Athletic Boosters are considering installing new restroom facilities at the football field where the old concession stand is presently. The Boosters asked about hooking into a sanitary sewer. Presently there is no sanitary sewer close to this area, but there is a sixinch line north of the village park restrooms. Discussion was had as to whether there would be enough gravity fall to hook into this line.

Mr. Schneck stated several future water related projects: 1) the replacement of the four-inch waterlines and 2) a new 200,000 gallon water tower. At a future council meeting, Poggemeyer will present to the Council updated proposals as to waterline replacement and new water tower. Also Richard Heyman of Poggemeyer Design Group, will be checking with EPA as to the phosphorus limits for wastewater effluent stated in Village's the NPDES permit. Mr. Heyman will report his results to the Council in the near future.

Mayor Schlumbohm presented his annual address before Council. Some of the highlights are: 1) The financial condition of the village increased approximately 47% from the previous year. 2) There are approximately 185 acres available for future economic development; 60 acres of village-owned property and 125 acres under an option with the Putnam CIC.

3) The playground at the Park was refurbished by way of a Natureworks Grant. A local contractor made the repairs and the local football team replaced the mulch with pebble stone ground cover. 4) There are several future projects for the new Council to consider: repairs to the open shelter house, the phosphorus issue with our lagoons, replacing waterlines, installing a new water tower, and hiring a new fiscal officer.

Mayor Schlumbohm stated he welcomed the four new council members and would like to thank the former council members for their work on council. Mayor Schlumbohm also stated he appreciated the good work of the staff members and police department this past year.

A plat prepared on behalf of the Hilty Home was presented to Council. Motion was made by Mr. Burkholder, seconded by Mr. Eisenbach to approve said plat. Voting: All Yea.

Motion was made by Mrs. Buess, seconded by Mr. Swary to contribute \$2,000 to each employee's HSA account for 2014. Voting: All Yea.

With no further business to discuss, the meeting was adjourned upon a motion by Mr. Swary, seconded by Mr. Burkholder. Voting: All Yea.
