The Pandora Village Council met in Regular Session on Tuesday, June 23, 2015 at 7:00 PM at the Municipal Building with Mayor John Schlumbohm presiding.

The meeting was opened with the Pledge of Allegiance.

Motion was made by Mr. Eisenbach, seconded by Mr.Swary to approve the June 9, 2015 minutes. Voting: All Yea.

Motion was made by Mr. Burkholder, seconded by Mr. Swary to approve the bills as presented; Total non-payroll of \$58,203.57 and payroll of \$22,174.17. Voting: All Yea.

RESOLUTION NO.2015-638: AUTHORIZING ALL ACTIONS NECESSARY TO EFFECT A GOVERNMENTAL ELECTRICITY AGGREGATION PROGRAM WITH OPT-OUT PROVISIONS PURSUANT TO SECTION 4928.20 OF THE OHIO REVISED CODE, DIRECTING THE PUTNAM COUNTY BOARD OF ELECTIONS TO SUBMIT A BALLOT QUESTION TO THE ELECTORS. Motion was made by Mr. Swary, seconded by Mrs. Miller to adopt RESOLUTION No. 2015-638 as read for its third and final reading. Voting: All Yea.

ORDINANCE NO.555-2015: AUTHORIZING THE LEASE OF APPROXIMATELY 56.039 ACRES, PLUS OR MINUS, OF REAL ESTATE OWNED BY THE VILLAGE OF PANDORA. Motion was made by Mr. Burkholder, seconded by Mr. Eisenbach to place ORDINANCE NO. 555-2015 on its second reading with the approved correction of stating "approximate acreage, plus or minus". Voting: All Yea.

ORDINANCE NO.556-2015: APPROVING THE PARTICIPATION OF THE VILLAGE OF PANDORA AS A COLLABORATIVE PARTNER WITH THE PUTNAM COUNTY COMMISSIONERS IN FILING A PETITION WITH THE PUTNAM COUNTY COMMON PLEAS COURT TO CREATE A REGIONAL WATER AND SEWER DISTRICT PURSUANT TO CHAPTER 6119 OF THE OHIO REVISED CODE. Motion was made by Mr. Swary, seconded by Mrs. Miller to place Ordinance No. 556-2015 on its second reading with the approved revisions. Voting: Burkholder-Nay; Eisenbach-Aye; Miller-Aye; Swary-Aye.

ORDINANCE NO.554-2015: AMENDING ORDINANCE 530-2011, 537-2012 AND 548-2014(FIXING RATES AND CHARGES FOR WATER SERVICE FOR THE VILLAGE OF PANDORA, PUTNAM COUNTY, OHIO, IT'S INHABITANTS AND OTHER USERS) AND REPEALING ALL ORDINANCES INCONSISTENT THEREWITH. Motion was made by Mr. Swary, seconded by Mr.Eisenbach to place Ordinance No. 554-2015 on its second reading with approved amendments. Amendments consisted of combining three existing water Ordinances into one, Shut off of water service will occur at 60 days delinquent (previously 30 days), No new Lessee shall be able to put water into their name without all outstanding/delinquent water bills being paid in full by the Lessee or Lessor and updating/clarifying language within the Ordinance. Voting: All Yea.

Council reviewed the Village Administrator's Report in Mr. Schneck's absence and the following was discussed: 1) Mower quotes and trade in scenarios were reviewed. Mayor Schlumbohm will contact Gary Augsburger to get further details on the trade in program that he is offering. This will be discussed again at the next meeting. 2) Mayor Schlumbohm informed Council that mosquito spraying will be done next week.

Council reviewed a quote from Ward Construction totaling \$34,950.00 for various street and alley repairs as well as curb and gutter repairs. Motion to approve the cost and repairs was made by Mr. Burkholder, seconded by Mr. Swary. Voting: All Yea.

Police Chief Stant stated that the Pandora Missionary Church will be holding a 5K Run on Saturday, July 25, 2015. This is a "glow run" and will start at 9:40 PM.
