ORDINANCE NO. 553-2015: ADOPTING AND ENACTING AMERICAN LEGAL PUBLISHING'S OHIO BASIC CODE, 2015 EDITION AS THE CODE OF ORDINANCES FOR THE MUNICIPALITY OF PANDORA, OH. RESOLUTION NO. 2015-636: TRANSFERRING FUNDS FROM GENERAL FUND TO PARK FUND. Motion was made by Mrs. Buess, seconded by Mrs. Miller to adopt Resolution No. 2015-636 as read for its third and final reading. Voting: All Yea.

Michael Seeger from Choice One Engineering was present to introduce himself and give a brief review of the services that they provide. Choice One is a civil engineering firm that can assist with grants and funding as well as doing the engineering work.

Resident Norm Stratford was present to ask questions regarding the recently adopted Snow Emergency Parking Ordinance. His questions and concerns were addressed and he thanked the Village Administrator and the other village employees for the good job they do with the snow removal.

The Village Administrator reported on the following: 1) The water main break that was reported on at the last meeting was located February 13th at 308 Welty Street and has been repaired. This break caused us to more than double the amount of water we normally use which resulted in a waste of Chlorine treatment as well. 2) The Mayor, Village Administrator and the Water/Sewer Committee met with representatives from Poggemeyer and the legal counsel for the proposed Black Swamp Regional Water and Sewer District. Documents were provided to all council members and will be discussed further at the next regular council meeting when all members will be in attendance. 3) The Bureau of Workers Compensation currently has grant money available to be used for the safety of employees. Mr. Schneck made some suggestions on how the Village could use this money. He will be in contact with the BWC to begin the application process.
