RESOLUTION NO. 2017-652: A RESOLUTION AUTHORIZING ALL ACTIONS NECESSARY TO EFFECT A GOVERNMENTAL NATURAL GAS AGGREGATION PROGRAM WITH OPT-OUT PROVISIONS PURSUANT TO SECTION 4929.26 OF THE OHIO REVISED CODE, DIRECTING THE PUTNAM COUNTY BOARD OF ELECTIONS TO SUBMIT A BALLOT QUESTION TO THE ELECTORS. Village Administrator, Rick Morrison, reported on the following: 1) Diller Street waterline replacement project has been completed. 2) A 10" Inserta Valve has been installed at the Water Plant. 3) Six of seven Fire Hydrants have been replaced. 4) The approach behind the Lunch Box has been repaired. 5) In the process of getting pricing for installing some meter pits. Eventually would like every house in town to have a meter pit. 6) The village maintenance workers have been busy replacing the roof on the aerator at the Water Plant and trimming at the Park and Lagoons. 7) Discussed with Council an alley at South Avenue and Sherman Street. Village Administrator and Village Solicitor will do further research to determine responsibility on the maintenance of this alley.

Council reviewed the Contractor's Application for Payment Request and Disbursement Request Form and Certification in the amount of \$95,934.36 for the current Water Main Improvement Project. was made by Mr. Burkholder, seconded by Mr. Eisenbach, to approve this third payment request.
