Motion was made by Mr. Tadena, seconded by Mr. Fricke, to approve the bills as presented: Total non-payroll of \$24,894.00 and payroll of \$7,096.83 for a total of \$31,990.83. Voting: All Yea.

Motion was made by Mr. Burkholder, seconded by Mrs. Braidic, to approve the Fund Summary, Bank Reconciliation and Bank Balance Reports for September, 2019. Voting: All Yea.

Motion was made by Mr. Tadena, seconded by Mrs. Braidic, to approve the Revenue and Appropriation Summary Reports for September, 2019. Voting: All Yea.

Village Administrator, Rick Morrison, reported on the following: 1) The tree has been taken down on Basinger Road that was approved in 2) Ultrasonic units and transmitters have been ordered from Sonic Solutions for the lagoons. 3) It has been determined that the lift station and valve vault on Road 4 are sitting too low. Mr. Morrison received a quote from Buckeye Pumps to correct this in the amount of It was the consensus of Council to move forward with this \$7,996.00. repair. 4) Dollar General project continues to run on schedule. South Avenue and Sherman Streets have been chip sealed however there are still potholes that need repaired. Wards will go back and fix these at an additional cost of \$2,900.00. 6) Mr. Morrison has received a complaint from a resident regarding a neighbor's yard with various junk items sitting in it. The village does not currently have an ordinance that addresses this particular issue. Mr. Morrison reviewed some other village's ordinances with Council. Mr. Morrison will work with village Solicitor, Scott Basinger, in drafting a letter to resident's asking them to clean up their property.
