**EMERGENCY ORDINANCE FOR AMENDMENT OF TRANSIENT DEALER
OR SOLICITOR PERMIT FOR THE VILLAGE OF PANDORA, OHIO**

I hereby acknowledge that the application fee for a Transient Dealer or Solicitor Permit is \$50.00 per person and that I will abide at all times by the time frame for such solicitation which has been set by the Village of Pandora as between 9:00 a.m. and sunset, but no later than 6:00 PM, Monday through Friday. Said Permit is valid for 5 consecutive business days from the date of issuance. I also acknowledge that if any information that I have provided is fraudulent and or a misrepresentation or if I breach any of the other requirements found in O.R.C. Section 715.64, that my Transient Dealer or Solicitor Permit may be temporarily suspended by a dully appointed Village of Pandora Police Officer on behalf of the Village of Pandora, until such time I may have a hearing of revocation of such Permit in accordance with section 112.06 of the O.R.C.

I hereby declare that the above given information is true and correct and agree to abide by all requirements therein.


SECTION I. That said new revision be hereby adopted and shall hereby replace said prior Transient Dealer or Solicitor Permit Application language.
